Customer information on the subject of REACH

Directive (EC) No. 1907/2006 (REACH Directive) and information obligation

Dear Sir or Madam,

With this customer information, we would like to answer questions that we are frequently asked on the subject of REACH.

The products supplied by SEW-EURODRIVE are considered 'products' according to REACH and fulfill all of the applicable requirements pursuant to Annex XVII of the REACH Directive.

As soon as SEW-EURODRIVE learns that one of its products contains a substance of very high concern (SVHC) from the latest ECHA candidate list (<https://echa.europa.eu/de/candidate-list-table>), which occurs in a concentration greater than 0.1% (w/w), then we will disclose it as per the information obligation pursuant to Article 33 of the REACH Directive. Based on information from our suppliers, we must assume that our standard products (gearmotors, motors, gear units, frequency inverters) contain lead (CAS-No. 7439-92-1) in a concentration of more than 0.1% (w/w). However, for the products within the scope of the RoHS Directive, lead is only used for purposes for which an exception in Annex III of the RoHS Directive 2011/65/EU applies.

Gear unit oils may also contain SVHC. If the SVHC content in the product exceeds 0.1%, this can be found in the order confirmation.

For auxiliary materials and operating supplies (e.g. lubricants and oils) that are supplied under the SEW-EURODRIVE trademark, we provide safety data sheets pursuant to Article 31 of the REACH Directive.
